## **Haymaking With Horses**



Haymaking in the late 1800s and early 1900s involved a lot of physical labor and the use of horse drawn farm implements. The first step was cutting the hay with a horse drawn hay mower. The mower had a seat for the operator who drove the team and two steel wheels with cleats that provided power from ground traction for the sickle bar. After letting the hay dry for a few days it was raked into windrows with a horse drawn dump rake. The dump rake had long curved tines that scooped up the hay, dragging it along until the driver raised the tines



Using a Buck Rake to Push Hay for Stacking dumping the hay into windrows. If the hay was to be loaded onto a wagon by hand, the horses were then driven down each windrow raking the hay into piles. The piles were then loaded onto the hay wagon by hand and hauled back to the barn or a haystack.



Albert Young used a "hay loader" to load windrowed hay onto his hay wagon out in the field. Horses pulled the wagon down the windrows with the hay loader hitched behind. The wheels powered the loader which picked the hay up off the ground and conveyed it up a slope onto rear end of the wagon.

One person riding on the wagon drove the team while one or two others distributed the load with pitch forks. In later years, Albert used a tractor to pull the wagon and hay loader. Sometimes during haying season, Albert would go to the county workhouse at South Range and hire a couple of prisoners to help with haymaking. The prisoners at South Range were allowed to leave during the day for work if they had a job lined up. Albert would pick the prisoners up in the morning and return them to the workhouse after each day of work.

# Unapproved GENERAL MEETING MINUTES OLD-BRULE HERITAGE SOCIETY, INC. Lakeside Town Hall, June 21, 2012

**CALL TO ORDER**: Following a pot-luck supper, President Alice Christensen called the meeting to order at 6:40 p.m.

**MINUTES**: Marion moved to approve the minutes, published in the June 2012 *OBHS News*, of the last General Meeting held on April 11, 2012. Following a second by MaryAnn, these minutes were approved.

**TREASURER'S REPORT**: Earl Tekippe was not available to provide a report. **OLD BUSINESS**:

Rinnet property: Jim reported that he has contacted Julia Burke Rinnet in the past regarding the site of the Rinnet house and property, which is located between two parcels that Jim owns in Maple. Dave Conley has been acting as the liaison with the Rinnet family in the present effort. Jim plans to meet again soon with Julia, Dave, and possibly Robert, to see what arrangements, if any, might be made with Julia to seek a temporary easement over this property, and its possible purchase.

Pollari Memorial Gift Committee: Lois, Audrey, Brian, and Jim are currently working on the Pollari Map. Jim noted that the completed map will include an index and additional information on the reverse side. Further work needs to be completed with Randy before the committee finalizes the map. While the committee has worked carefully to ensure that the final product is correct, a disclaimer will be included. Lois reported that the committee will make a final recommendation at an upcoming general meeting.

Scandinavian Dinner & Tours:

Dinner-- Volunteers will meet at 8:30 on Friday morning (June 22) to prepare the dinner. On Saturday morning (June 23) workers are asked to arrive beginning at 7:30 a.m. Barbra will set up table decorations. Dinner will be served from 11:00 a.m. -2:00 p.m. Brian and Karin will sell tickets during that time.

Mary Ann has advertised the dinner in various publications, including a \$40 ad in the *Superior Telegram*. About 40 posters are on display around the area.

Davidson Mill—Jack Pank will provide tours on both Friday and Saturday.

Eskolin House--Shirley will staff the Eskolin House on both days.

Taylor's Bridge: Brian reported that recent rains caused some erosion on the north end of the bridge. He worked on the site the previous week and will do more work, depending upon the availability of Olson Brothers to deliver 17 more yards of rock and 17 yards of Class 5. Our goal is to obtain a bridge surface for the display of antique vehicles. Lila provided Shirley with written information about the bridge for distribution to visitors. Eventually, a brochure could be developed.

Next Board Meeting: The next board meeting will be held on Wednesday, July 11, 2012 at the Eskolin House.

Annual Meeting—After discussion about various sites and dates, Jim made a motion, seconded by Shirley, that our Annual Meeting be held on Sunday, August 19<sup>th,</sup> beginning with a

pot-luck picnic at 1:00 p.m., with the tentative site at the Maple Pavilion/Ball Park. The motion passed. Paul, after checking on the availability of this site, will contact Alice. OBHS will provide brats; Shirley will bring water.

OBHS Annual Northwestern High School Scholarship Recipient – Audrey reported that Abigail Schulz is the recipient of the OBHS 2012 Scholarship. Jim provided Audrey, for her history, the copy of the letter we received addressed to Miss Schulz from the high school informing her of her selection.

Election of New Board Members—A slate of new board members will be presented to the membership at the Annual Meeting. Paul Colby, Dennis Hill, Brian Paulson, and Jim Pellman will be entering the 2<sup>nd</sup> year of their 1<sup>st</sup> term. ### Unapproved Board Meeting Minutes OLD-BRULE HERITAGE SOCIETY, INC. Eskolin House, Town of Lakeside, July 11, 2012

Members Present: President Alice Christensen, 1<sup>st</sup> Vice-President Earl Granroth, 2<sup>nd</sup> Vice-President Brian Paulson, Secretary Lila Ronn, Acting Treasurer Earl Tekippe, Karin Colby, Dennis Hill, Jim Pellman, Eddie Walman, and Nancy Wiitala.

**CALL TO ORDER**: President Alice Christensen called the meeting to order at 4:50 p.m.

**MINUTES**: Earl G. moved to accept the minutes of the previous Board Meeting held on May 9, 2012 as published in the June *OBHS News*. Following a second by Karin, the minutes were approved.

TREASURER'S REPORT: Earl T. did not have an official report from the National Bank of Commerce available. He reported that all bills received to date have been paid. OLD BUSINESS:

Scandinavian Dinner and Mill/Eskolin House Tours: Alice reported that 75 dinner tickets were collected in the designated container, but it is possible a few more tickets were purchased. Remaining food was also sold. Dennis noted that only a half dozen people attended the tours, but that attendance was definitely affected by the closure of State Highway 13.

OBHS recognized a profit of \$ 590.97 on the meals and merchandise. Donations totaled \$ 45.00.

Mill/Eskolin Open House & Tour Dates -- Summer, 2012

Jim volunteered to be present at the site on July 21 and Jim and Nancy will be there on August 18. The hours will be 10:00-3:00.

Rinnet Property & Monticello School: Jim reported that he, along with Delores Pellman and Jan and Dave Conley, have met with Julia and Toivo Rinnet and Toivo's nephew, Robert Rinnet, near the proposed school site. Mike McKercher who owns adjacent property also was present and expressed agreement with proposed plans. Julia has agreed to allow us to bring in the Monticello School across her land, which parcel is between two parcels owned by Jim.

Jim said that the Monticello School, in its drier condition, and feels more sound. The TyVek is working well. He took some tight measurements. The 1/8-inch thick siding is not original, because it was installed very long ago across the window openings. The building was built with just a board frame construction. Checking on early photographs will give us some idea of the width of siding boards that were used initially. The 8" board drop siding used on the porch addition appears to be authentic.

Materials from the old N.P. Johnson School might be salvageable. Larry Johnson, current owner of the property, could be contacted.

Concern was expressed about the cost of moving the Monticello School to the proposed Maple site. OBHS has a commitment to maintain the Davidson Windmill and has received Town of Lakeside approval and a County Variance in support of our decision in April 2011 to build some type of addition to the Eskolin House. Where will we get the money to move the Monticello School?

Jim noted that Phase 1 of the project would include moving the small school (18'x24') on to a temporary footing on the Maple site where it could be worked on. Dennis made a motion, seconded by Earl G., that OBHS proceed with Phase 1. The motion was approved. Before this project is presented at the Annual Meeting for approval, Jim will drive the project and get good estimates of the cost for Phase 1 and develop a plan for financial support.

Membership Drive: Dennis has developed a letter to send to Maple residents, inviting them to attend an OBHS meeting in October, with hopes of increasing our membership. A special program needs to be planned soon.

Taylor's Bridge Project: Brian reported the rock has been delivered. The hand-railing design is still to be determined, but wood will not be used. Erosion appears to under control.

Next Board Meeting: 4:30 p.m., September 12, 2012 at the Eskolin House

#### **NEW BUSINESS:**

Annual Meeting/Picnic: The Annual Meeting will be held on Sunday, August 19, 2012, at the Maple Town Shelter by the ball field. The potluck picnic will begin at 1:00 p.m. Brats and beverages will be provided. We will reserve the ball field to improve availability of the shelter. Karin will confirm our reservation at the upcoming Town of Maple Board Meeting.

Election of New Board Members: Out-going board members will serve as a committee to present a slate of potential members for the next term of two years. Immediately following the Annual Meeting, the new Board of Directors will elect officers.

Historian Replacement: Audrey Hakkila has creditably served as historian for many years, but has requested to be replaced. As the new Board determines their officers, they will consider how to best fill this important role.

Possible Field Trips: Brian suggested that OBHS consider a field trip to the John Beck Log House in Solon Springs (Solon Springs Historical Society). Another possibility is a trip to Oulu to visit the Palo Homestead ( Lahti Farm) and the Pudas Homestead. Alice will follow-up with more information.

Security/Use of Keys at Davidson Mill/Eskolin House Site: Dennis questioned the vulnerability of the current system that board members use to enter these buildings. Earl G. made a motion that Dennis develop a "key plan" to allow members access without jeopardizing security. Following a second by Nancy, the motion passed.

**ADJOURNMENT**: Earl moved to adjourn the meeting; Dennis seconded the motion. The meeting was adjourned at 6:15 p.m.

## Area Gistory: No. 85

The following text and image are from the month of July in the 2012 OBHS Annual Historical Calendar.

7. Pollari Well Drilling Rig, c. 1920. The earliest picture of the first Pollari churn well drilling rig, shows Ted Pollari at about 16, an unknown helper, and John Pollari, Maple based well driller, then fifty-five years of age. John was born in Veteli, Finland in 1865, came to



America in 1893, living in the Finnish colony in Lanesville, Massachusetts, working in a granite quarry there until 1899 when he was pressured to leave because of his religious activities. He was forced to abandon a substantial boarding house that he had constructed there. His family came via Upper Michigan to Maple, then part of Old Brule, where he continued his preaching within the Laestadian Independent Apostolic Lutheran tradition. Several of his followers in Massachusetts came to live in Maple as well. He established a farm on Peyton, Kimball & Barber cutover lands in the area of Maple called Kaskenperä. He remained active in the well business until late in life. His death came in 1945 while on a preaching trip to Upper Michigan. His son Charlie had become active in the business, with a new rig purchased in the 1930s. His untimely death due to a heart attack in 1949 ended the business, a year in which he did some drilling with the Longs. The spiritual message of life from Rev. John Pollari through his son Ted's life was that we live lives of non-coerced service to one another, to our neighbors, not because of what he or she has done, but because of what our creating Divine Father has done, in the Creation itself, and though fallen, He brings it back, redeemed through his own re-creative love and suffering, which sacrificial love and giving is the essence, the ultimate nature of Reality itself. Human life is not zero-sum: Our own free giving is the creation or generation of new life itself. The old church building that John preached in and designed is perhaps the last of the Finnish Kuorikoski churches. His mother was a daughter of Kuorikoski church builders from Kaustinen.
