OLD-BRULE HERITAGE SOCIETY FEBRUARY GENERAL MEETING Wednesday, February 13, 2013, 6 p.m. at the Brule Town Hall

Program: Our speaker will be Board Member and Secretary, Jim Pellman, who will talk on the early history of the Town of Brule, using photos and old maps, and images from our latest calendars. He will also review progress surrounding the move of the Monticello School from the Town of Lakeside to our Maple Hill Historic Site. After a break for refreshments a short business meeting will follow. Thanks to the Town of Brule for the use of their Town Hall, and to all who bring refreshments to share.

FROM THE EDITOR:

There is activity on a park-like vacant lot a block from Northwestern High School in Maple. The Monticello School is on the move and will soon be located a few yards from the site of the earliest Town of Brule Town Hall. It will be on the lot which was adjacent and dedicated to the first School District 3 school of the old Town of Brule. This school just happened to be in the village of Maple. This building's move will be the first step in a project that will not only save this historic structure, but because it will be built over a full, modern walk-out basement, will allow Old-Brule Heritage Society to more completely fulfill its original charge: to preserve and share the history of the Old Brule region. It is part of the vision shared by the earliest membership of Old-Brule Heritage Society, which saw itself as a historical society to serve the communities that feed their children into the School District of Maple, or Northwestern, schools.

An important responsibility of any historical group is its collection, and the facilities needed to take care of them, and to interpret and display them. Other than the buildings at the Windmill site we have relied on the generosity of our communities and our members for space to allow us to perform our duties. For this we thank them all. Yet this has made us vulnerable to the inevitable demands of changing community needs and human circumstances. When the Monticello School Museum and Archives is complete, we will have a place and a mailing address totally our own, for the first time, to fall back upon. We thank all who see the vital importance of this project to our group and our vision, and who are contributing, each in his or her own way, to its future success. - Jim Pellman

1998 to 2005, 2006 to 2013 LOCAL HISTORY PHOTO CALENDARS FOR SALE.



3. Hawthorne, Nebagamon & Superior Railroad Caboose Derailment, c. 1905. This photograph

was taken during the time of the HN & S shortline railroad. built Frederick Weyerhaeuser 1898 interests in the connect large Nebagamon Lumber Company mill with the Chicago, St. Paul. Minneapolis & Omaha Railroad in Hawthorne (the Omaha), avoiding the need to deal with the Duluth. South Shore & Atlantic Railroad which also served the village of Lake Nebagamon, but via



the City of Superior. The HN & S also ran several branches north into the company's pine land holdings throughout old Brule. This derailment undoubtedly required immediate attention as it happened on the main line just as it left Lake Nebagamon, and at the point where the branch from the Poplar direction and north (now Highway P) arrived into Lake Nebagamon. Unapproved BOARD MEETING MINUTES OLD-BRULE HERITAGE SOCIETY, INC.

Hope Swenson residence, Town of Lakeside, January 9, 2013

Members Present: Dennis Hill, Brian Paulson, Jim Pellman, Mary Ann Gronquist, Hope Swenson, Earl Tekippe, Gary Luoma, Alternate; (One board vacancy).

CALL TO ORDER: Dennis Hill called the meeting to order at 4:30 p.m.

MINUTES: Motion for approval of the minutes of the previous Board Meeting held on November 14, 2012 at the Eskolin House, as published in the Dec 2012-Jan 2013 *OBHS News*, by Mary Ann G. Second by Gary Luoma. Motion carried.

TREASURER'S REPORT: Earl Tekippe: As of 1/9/2013: CD: \$5733.76;

Poplar Bank Checking Account: \$3624.06. Motion for approval by Jim Pellman, seconded by Hope Swenson. Motion carried. Earl T. then in a surprise advised us that he would be resigning from his post as Treasurer, effective immediately. He explained that he had not been fully aware of the range of our organization's wider vision at the time he agreed to the office, thinking our efforts were mostly confined to maintenance of the Windmill site. After gallant efforts to get him to change his mind we regretfully resigned ourselves to his departure, but persuaded him to carry on until our next general meeting in February.

OLD BUSINESS:

Davidson Windmill/Eskolin House/Taylor's Bridge Committee:

Chairman Brian Paulson Report: Bids for painting mill will wait until April.

Maple Hill OBHS Monticello School Museum and Archiving Facility:

Report: Erkkila legal transfer documents completed. Letter arrived from DC Zoning 11/13/12 for our representatives to appear before DC Board of Adjustment regarding issuance of variance on 11/28/12, Wednesday, 10:00 a.m. Jim P. attended and spoke for OBHS. Dennis & Arlene also were there. Unanimous approval was granted by the hearing committee on driveway

location issues: Hwy 2 set back and separation from neighbor issues. Fee for this: \$475.00. Bid has been secured on Phase I moving of school from Woodhulls: \$3500 for initial move, \$1500 for move from crib on final site to new basement, to be accomplished around February 1, 2013. A motion was made by Jim, and seconded by Mary Ann, to approve this bid from Woodulls, pending their demonstration of insurance and licenses. Jim assured the group that he would arrange funding out of his own resources as necessary to back the Phase I bid amount. Motion carried.

Dennis has been prepping the site. Woodhulls propose moving the school directly off Highway 2 onto the corner Maple Hill lot, bypassing the Rinnet's property. Bill Anderson has agreed to survey the precise lot lines *pro bono*.

Once on site: preliminary roof repairs, and winterizing, as needed. Thorough vision and planning documents need to be drafted for Phase II, and letters thoroughly describing the basement construction plans for Phase II will be needed with requests for bids and help to go out to local contractors: possibly Glen & Mike Hill, Kevin Maki, Poolers, Gary Peterson, Scott Essen, Olson Brothers, others?

Materials from the old N.P. Johnson School might be salvageable. Larry Johnson, current owner of that property, could be contacted. Eddy has an old building with drop siding that can be salvaged and used. Axel Wiitala has siding from the old Maple Hall he is willing to donate. A final estimate of the costs involved should be generated. A tentative date of completion should be formalized as early as possible.

More planning is needed regarding Phase II fund-raising, further specific fund-raising from within our own group, a possible public campaign, grant writing to groups like the Duluth-Superior Area Community Foundation, Wisconsin Humanities Council, Finlandia Foundation, and others. Matching grants should be sought. Local banks, businesses and corporations should be contacted for what help they might be able to give us. A packet needs to be prepared that describes and itemizes all phases and needs within the project that can be presented on contacts and visits to potential donors at all levels.

Dennis and Jim have been in contact with the Conleys in Florida, and Jan has offered her services in our designing a fund-raising campaign. Two new brochures are proposed in support of these efforts. Jim will be supplying Jan with documents, images and maps in support of this work to be done with the digital help of Jan's daughter. Jim hopes to help with this as his health returns.

A 36 inch culvert will be needed once we move to the Highway F driveway project. These can cost \$600. We will seek to coordinate our work with the County and the DNR as requested to help mitigate costs in this area.

Architect, Robert Aho, might be contacted to assist us if possible.

The letter acknowledging the Rantala Family Log House offer still needs to be drafted and sent; was not addressed at this meeting.

Membership Committee: Membership Drive planning: for Brule and Lake Nebagamon. Letters, as before, to go out to Brule, and then LN prospective members, and others, inviting them to attend a coming OBHS General Meeting. A PowerPoint talk can be prepared for the specific community audience. Dennis would talk on historic kitchen tools.

Recognition Certificates for latest retired Board members, and recognition for hours donated last year should be part of the next General meeting; was not addressed at this meeting.

Archives Committee: Next meeting: January 14th at Delores Pellman's.

Publications Committee:

New Monticello School Museum Bank Account: Jim moved that we create a separate account for deposit of donations received designated for the Monticello School Museum and Archive. Mary Ann seconded the motion. (Discussion followed shortening the name of the account to Monticello School Museum.) There would be created an actual separate Monticello School Museum checking account at the bank in Poplar to hold donations coming in dedicated specifically to that purpose. There was also discussion having to do with the sources of funding for the school project, Phases One and Two, these having to do with the preparation and move and of the School, and then for construction of the museum/archiving basement. Earlier minutes expressly say that these will be done with new funds raised for the project. We have other dedicated funds in our accounts which commitments are to be met, not least the Windmill maintenance itself, and these are not to be touched. With these assurances the motion on creation of a new account carried.

Trunk available from Douglas County Historical Society: Jim Mattson from the Douglas County Historical Society Archive stopped at our last Board meeting, and proposed we examine a duplicate trunk held by DCHS that is available. Jim P. was to investigate, but cancelled due to health, but will do so soon.

Sympathy/Encouragements: Hope has been handling these and needs leads.

Button Creation: in support of an OBHS logo adoption and new T-Shirt, and for fund raising for our new Maple Hill museum. Discussed a possible design contest.

The following text and image are from the month of April in the 2013 OBHS Annual Historical Calendar.

4. Swedish Homesteaders, John M. M. and Annie M. Peterson's Log House and Farmstead in Poplar, 1887, Located in Section 6, T47N-R11W. On the Fifth of April 1887 the Town of Brule held its First Annual Town Meeting at this site as part of the great division of the Town of Superior

which had covered all of Douglas County. (Gordon and Nebagamain also became new towns at the same time.) The Poll List for the new town of Brule included fifty-one voters, all men, and was certified by new Town Clerk, C. S. Howard. Merchant Thomas Doherty with 39 votes was named winner in the tally for Chairman soundly defeating other nominees, saw mill owner, J. E. Chase, 12 votes, and George Foltz, 10 votes. The meeting was held in this house, one near the Poplar Station on the Northern Pacific Railroad. It would be two years before Brule would have a Town Hall, and that would be located not at the Poplar or



the Brule Stations but near the centrally located Maple Station. Poplar would never legally exist as a Town, but was part of the Town of Amnicon after 1906 until the Village of Poplar was finally created in 1917. "Double M" would become Poplar's first postmaster, and the Peterson family would grow to eleven members. In 1932 they were living in Oregon.
